How?	All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons CapSouth Partners, Inc. chooses to share; and whether you can limit this sharing.

What we do

How does **CapSouth Partners, Inc.** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We use certain internet and email specific practices such as firewall barriers, encryption and authentication procedures for online privacy.

How does **CapSouth Partners, Inc.** collect my personal information?

We collect your personal information, for example, when you

- Seek financial advice or seek advice about investments
- Enter into a contract with us or request a wire or ACH
- Fill out forms related to services CapSouth provides

Utilize CapSouth to build, review or amend a financial or estate plan.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *CapSouth Partners, Inc. currently does not have any affiliates.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Nonaffiliates can include attorneys, accountants, custodians, etc. We will only share your information with nonaffiliates with your authorization and for the purpose of providing services to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *CapSouth Partners, Inc. doesn't jointly market.*

Other important information

CapSouth shares personal information with unaffiliated business partners in order to provide various services to clients. No mobile information or other contact information will be shared with any third-parties for marketing or promotional purposes. If a client has consented or opted in to receiving text messages from CapSouth, this opt-in data and consent will not be shared with any third parties.
